Terms & Conditions

1. A provisional booking will only be held for 2 weeks, unless confirmed by the deposit the date shall be automatically cancelled.
2. To confirm and guarantee the reservation we request a non refundable deposit of €1,000.00. This deposit may be paid by Cash, Bankers Draft or Credit Card. We also require a signed copy of our terms and conditions. The remaining payment of the estimated amount will be due one month prior to the event.
3. The MV Cill Airne reserves the right to cancel or refund deposits in circumstances when a booking is made through a third party or under false pretences. Prospective clients must always meet with a member of management by appointment prior to acceptance of the first deposit. Deposits must be paid in person to the MV Cill Airne; otherwise we reserve the right to cancel the booking.
4. Should you be forced to postpone your date booked, the original deposit paid to the MV Cill Airne may be transferred to another date within 6 months of the original booking.
5. A cancellation must be made in writing. Cancellation charges in addition to the forfeit of the original deposit will be charged in full if the wedding is cancelled within 12 weeks of the date booked.
6. Minimum numbers apply for exclusive use of the Quay 16 Restaurant; Sunday-Wednesday: 40 persons, Thursday-Saturday: 50 persons.
7. Full menu details are required four weeks prior to your wedding day.
8. Final numbers are required 48 hours prior to your reception and they will be the minimum number charged for; should your numbers decrease on the day of your function the original confirmed number given stands.
9. No beverages of any kind will be permitted to be brought on to the premises by the patron or any of the patrons guests, without special permission granted by the venue. This clause does not apply to the Wedding Cake.
10. Corkage can only be negotiated and agreed in writing in advance with consent of our wedding coordinator.
11. A bar extension can be provided; arrangements for same require two months prior notice.
12. The MV Cill Airne accepts no responsibility for the loss or damage of any items of equipment, furnishings, or other property by the customer or persons authorised by the customer.
13. The organiser shall be responsible for any damage to fittings and furnishings caused during the function.
14. The MV Cill Airne may cancel the event in the following circumstances: should any guest attending the function behave in anyway considered to be detrimental, offensive or contrary to normal expected standards of behaviour.
